If mists or sprays of this product are inhaled, they may mildly irritate the nose and other tissues of the upper respiratory system. Symptoms are generally alleviated upon breathing fresh air.

**SYMPTOMS/EFFECTS AFTER EYE OR SKIN CONTACT:** Depending on the duration and concentration of exposure, eye contact may cause tearing and redness. Skin contact may cause mild redness, discomfort, and irritation. Symptoms are generally alleviated upon rinsing. Repeated skin contact may cause dermatitis (dry, red skin).

## 12. ECOLOGICAL INFORMATION, continued

**PERSISTENCE AND BIODEGRADABILITY:** The product has not been tested for persistence or biodegradability. The components of this product are relatively stable under ambient environmental conditions. Additional environmental data for components of this product are available as follows:

### **DIMETHYLPOLYSILOXANE:**

Water Solubility: Insoluble.

Terrestrial Fate: If released to soil, Dimethyl Siloxane will absorb strongly and will remain essentially immobile. Dimethyl Siloxane will not volatilize to the atmosphere, nor will it biodegrade. Dimethyl Siloxane will not undergo hydrolysis except in clay soils which are known to catalyze this reaction at a rate dependent upon the amount of water present.

Aquatic Fate: If released to an aquatic environment, Dimethyl Siloxane is expected to absorb strongly to sediment and suspended organic matter. Although insoluble in water, Dimethyl Siloxane is not expected to bioconcentrate, due to its inherent hydrophobicity. Dimethyl Siloxane will not bioconcentrate in fish and aquatic environments as this compound is molecularly too large to pass through biological membranes and concentrate in fatty tissue. Dimethyl Siloxane will hydrolyze in water and will not volatilize to the atmosphere.

Atmospheric Fate: If released to the atmosphere, Dimethyl Siloxane will only enter the atmosphere if in aerosol form, due to its heavy molecular weight, very low vapor pressure and liquid physical state. The most likely atmospheric fate process is by dry deposition to the surface of the earth.

### **ISOPROPYL ALCOHOL:**

Octanol/Water Partition Coefficient: Log P = 0.34–0.5

Persistence: If released to the soil, Isopropanol will both rapidly evaporate and leach into the ground due to high vapor pressure and low adsorption to soil. If released to water, Isopropanol will volatilize, with an estimated half-life of 5.4 days. If released to the atmosphere, Isopropanol will photodegrade, with an estimated half-life of one to several days. Due to the solubility of Isopropanol in water, rainout may be significant.

Biodegradation: In soil, and water, degradation of Isopropanol has not been determined. If soil degradation is not rapid, it will likely leach to groundwater.

**BIO-ACCUMULATION POTENTIAL:** This product has not been tested for bio-accumulation potential.

**MOBILITY:** This product has not been tested for mobility in soil.

**OTHER ADVERSE EFFECTS:** No components of this product are listed as having ozone depletion potential.

**ENVIRONMENTAL EXPOSURE CONTROLS:** Controls should be engineered to prevent release to the environment, including procedures to prevent spills, atmospheric release and release to waterways.

## 13. DISPOSAL CONSIDERATIONS

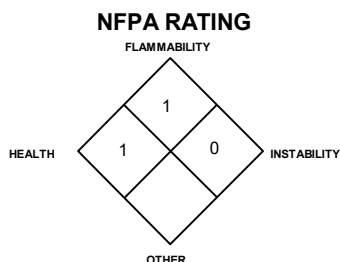

## DEFINITIONS OF TERMS

A large number of abbreviations and acronyms appear on a SDS. Some of these which are commonly used include the following:

**CAS #:** This is the Chemical Abstract Service Number that uniquely identifies each constituent.

### EXPOSURE LIMITS IN AIR:

**BEI - ACGIH Biological Exposure Indices,** represent the levels of determinants which are most likely to be observed in specimens collected from a healthy worker who has been exposed to chemicals to the same extent as a worker with inhalation exposure to the TLV.

**CEILING LEVEL:** The concentration that shall not be exceeded during any part of the working exposure.

**IDLH-Immediately Dangerous to Life and Health:** This level represents a concentration from which one can escape within 30-minutes without suffering escape-preventing or permanent injury.

**LOQ:** Limit of Quantitation.

**MAK:** Federal Republic of Germany Maximum Concentration Values in the workplace.

**NE:** Not Established. When no exposure guidelines are established, an entry of NE is made for reference.

**NIC:** Notice of Intended Change.

**NIOSH CEILING:** The exposure that shall not be exceeded during any part of the workday. If instantaneous monitoring is not feasible, the ceiling shall be assumed as a 15-minute TWA exposure (unless otherwise specified) that shall not be exceeded at any time during a workday.

#### MORPHOLINE:

If released to soil, this compound may volatilize from dry soil surfaces, but not from moist soil. This material in soil will move with soil moisture and is expected to leach out extensively. Based on screening test results, biodegradation may be significant, but only after a long adaptation period. When released to natural waters this material will not tend to bio-concentrate, volatilize, or sorb to sediment or organic particulate matter in the water column. While morpholine is biodegradable in screening tests, it is unlikely that significant morpholine degradation would occur because of the long lag period required. This compound reacts with photochemically-produced hydroxyl radicals in the atmosphere resulting in an estimated half-life of 2.6 hrs.

#### OLEIC ACID:

If released to air, a vapor pressure of 5.46X10<sup>-7</sup> mm Hg at 25°C indicates this compound will exist in both the vapor and particulate phases in the atmosphere. Vapor-phase material will be degraded in the atmosphere by reaction with ozone; half-lives of about 2.1 and 1.4 hours for the cis- and trans- isomers, respectively, are calculated for this reaction. Particulate-phase oleic acid will be removed from the atmosphere by wet or dry deposition. This compound does not contain chromophores that absorb at wavelengths > 290 nm and therefore is not expected to be susceptible to direct photolysis by sunlight. If released to soil, non-dissociated material is expected to have no mobility based upon an estimated K<sub>oc</sub> of 340,000. The pK<sub>a</sub> of oleic acid is 5.02, indicating that this compound will exist almost entirely in anion form in the environment and anions generally do not adsorb more strongly to soils containing organic carbon and clay than their neutral counterparts. Biodegradation is expected to be an important fate process in soil based on half-lives of 0.2 and 0.66 days in screening tests. If released into water, this compound (if in non-dissociated form) is expected to adsorb to suspended solids and sediment based upon the estimated K<sub>oc</sub>. This material was biodegraded 25-30% in the water column in field studies. Based upon the pK<sub>a</sub> this material will exist almost entirely in the anion form at pH values of 5 to 9 and therefore volatilization from water surfaces is not expected to be an important fate process. Hydrolysis is not expected to be an important environmental fate process since this compound lacks functional groups that hydrolyze under environmental conditions.

Because this compound is miscible with water and has a very low measured octanol/water partition coefficient, log K<sub>ow</sub> -0.86, its tendency to bio-concentrate in aquatic organisms should be extremely low. An experimentally determined BCF for morpholine was < 2.8.

#### OLEIC ACID:

An estimated BCF of 10 was calculated in fish for this compound, using a log K<sub>ow</sub> of 7.64 and a regression-derived equation. According to a classification scheme, this BCF suggests the potential for bio-concentration in aquatic organisms is low.

The  $pK_a$  of oleic acid is 5.02, indicating that this compound will exist almost entirely in anion form in the environment and anions generally do not adsorb more strongly to soils containing organic carbon and clay than their neutral counterparts.

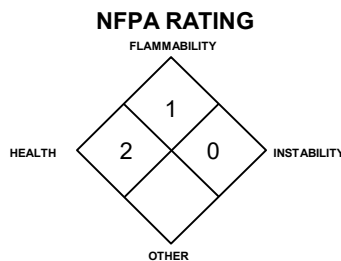

# DEFINITION OF TERMS

**IDLH-Immediately Dangerous to Life and Health:** This level represents a concentration from which one can escape within 30-minutes without suffering escape-preventing or permanent injury.

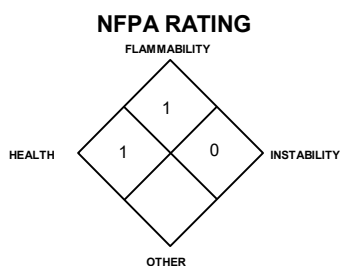

**INSTABILITY HAZARD:** **0** Materials that in themselves are normally stable, even under fire conditions. **1** Materials that in themselves are normally stable, but that can become unstable at elevated temperatures and

pressures. **2** Materials that readily undergo violent chemical change at elevated temperatures and pressures. **3** Materials that in themselves are capable of detonation or explosive decomposition or explosive reaction, but that require a strong initiating source or that must be heated under confinement before initiation. **4** Materials that in themselves are readily capable of detonation or explosive decomposition or explosive reaction at normal temperatures and pressures.

## FLAMMABILITY LIMITS IN AIR:

Much of the information related to fire and explosion is derived from the National Fire Protection Association (NFPA). **Flash Point** - Minimum temperature at which a liquid gives off sufficient vapors to form an ignitable mixture with air. **Autoignition Temperature:** The minimum temperature required to initiate combustion in air with no other source of ignition. **LEL** - the lowest percent of vapor in air, by volume, that will explode or ignite in the presence of an ignition source. **UEL** - the highest percent of vapor in air, by volume, that will explode or ignite in the presence of an ignition source.

## TOXICOLOGICAL INFORMATION:

**Human and Animal Toxicology:** Possible health hazards as derived from human data, animal studies, or from the results of studies with similar compounds are presented. Definitions of some terms used in this section are: **LD<sub>50</sub>** - Lethal Dose (solids & liquids) which kills 50% of the exposed animals; **LC<sub>50</sub>** - Lethal Concentration (gases) which kills 50% of the exposed animals; **ppm** concentration expressed in parts of material per million parts of air or water; **mg/m<sup>3</sup>** concentration expressed in weight of substance per volume of air; **mg/kg** quantity of material, by weight, administered to a test subject, based on their body weight in kg. Other measures of toxicity include **TDLo**, the lowest dose to cause a symptom and **TCLo** the lowest concentration to cause a symptom; **TD<sub>01</sub>**, **LDLo**, and **LDo**, or **TC**, **TCo**, **LCLo**, and **LCo**, the lowest dose (or concentration) to cause lethal or toxic effects. **Cancer Information:** The sources are: **IARC** - the International Agency for Research on Cancer; **NTP** - the National Toxicology Program, **RTECS** - the Registry of Toxic Effects of Chemical Substances, **OSHA** and **CAL/OSHA**. IARC and NTP rate chemicals on a scale of decreasing potential to cause human cancer with rankings from 1 to 4. Subrankings (2A, 2B, etc.) are also used. **Other Information:** **BEI** - ACGIH Biological Exposure Indices, represent the levels of determinants which are most likely to be observed in specimens collected from a healthy worker who has been exposed to chemicals to the same extent as a worker with inhalation exposure to the TLV.

## ECOLOGICAL INFORMATION:

EC is the effect concentration in water. **BCF** = Bioconcentration Factor, which is used to determine if a substance will concentrate in lifeforms which consume contaminated plant or animal matter. **TL<sub>m</sub>** = median threshold limit; Coefficient of Oil/Water Distribution is represented by **log K<sub>ow</sub>** or **log K<sub>oc</sub>** and is used to assess a substance's behavior in the environment.

## REGULATORY INFORMATION:

### U.S. and CANADA:

**ACGIH:** American Conference of Governmental Industrial Hygienists, a professional association which establishes exposure limits.

This section explains the impact of various laws and regulations on the material. **EPA** is the U.S. Environmental Protection Agency. **NIOSH** is the National Institute of Occupational Safety and Health, which is the research arm of the U.S. Occupational Safety and Health Administration (**OSHA**). **WHMIS** is the Canadian Workplace Hazardous Materials Information System. **DOT** and **TC** are the U.S. Department of Transportation and the Transport Canada, respectively. Superfund Amendments and Reauthorization Act (**SARA**); the Canadian Domestic/Non-Domestic Substances List (**DSL/NDL**); the U.S. Toxic Substance Control Act (**TSCA**); Marine Pollutant status according to the **DOT**; the Comprehensive Environmental Response, Compensation, and Liability Act (**CERCLA** or **Superfund**); and various state regulations. This section also includes information on the precautionary warnings which appear on the material's package label. **OSHA** - U.S. Occupational Safety and Health Administration.

**EUROPEAN:** **EU** is the European Union (formerly known as the **EEC**, European Economic Community). **EINECS:** This is the European Inventory of Existing Chemical Substances. The **ADR** is the European Agreement Concerning the International Carriage of Dangerous Goods by Road and the **RID** are the International Regulations Concerning the Carriage of Dangerous Goods by Rail. **AUSTRALIAN:** **AICS** is the Australian Inventory of Chemical Substances. **NOHSC:** NATIONAL OCCUPATIONAL HEALTH & SAFETY CODE.
